Dear Judge,

My name is Paul Guthrie. I am a natural born citizen of the United States, i.e., an Article II “natural born Citizen”, who is also a citizen of Indiana living in Madison County. I have been compelled by law to provide you with state’s evidence, as I am a witness to, and a victim of, very serious criminal conduct occurring in the county, State, and federal prosecutors’ offices by government employees, and even some very serious criminal activity occurring in the federal courts by government employees, and very possibly, in the County Courts.

I cannot go report to the various prosecutors’ offices because they are predominantly the ones who are engaged in the criminal activity and criminal obstruction of justice, and thus have shown themselves unable to police themselves over the last almost 8 years under the fraudulent imposter and criminal usurper Obama. Also, the nature of the criminal activity is one of Misprision of Felony 18 USC 4, Misprision of Treason 18 USC 2382, and Seditious Conspiracy 18 USC 2384, for the purpose to foment rebellion and insurrection within the United States with Presidential elections, in order to overthrow the United States Constitutional Republic and erect a dictatorship. A coup d’état which has already happened in 2008/9 with the fraud Obama being illegally and unlawfully installed in Office as a non-natural born Citizen, and is now happening again with Cruz and Rubio, who are not natural born Citizens either. All of this criminal political activity, sedition, and High Treason is occurring at both the State and Federal levels, all of which instruct me to bring my evidence before a judge as a legal option.

Whenever I have stepped forward with the evidence of criminal wrongdoing over the last 7+ years under Obama, the judges and prosecutors have just ignored the evidence and swept the matter under the rug, denying the due process and preventing it; thereby

threatening my life by making me subject to severe slander, defamation, ridicule, and death threats. They have refused to do their jobs to enforce the rule of law, apparently because it is not in their financial interest or in their political interest to do so. As a result, it has led to the overthrow of the government and to the stripping of all of my rights as a natural born Citizen, and yours, too, and also of your future progeny and your offspring's future progeny, etc. All their rights and identity as natural born Citizens is now in jeopardy, but you likely do not realize it, because you likely do not comprehend the law governing natural born Citizen (nbC) status.

Whether you realize it or not, or believe it or not, from now on that is irrelevant. From my perspective, I have given you the law and evidence of the most serious criminal political activity in American history (documents enclosed), which causes you to have constructive knowledge that crimes are being committed, which triggers a lawful and legal duty for you to report these crimes to the appropriate State and Federal Prosecutors' offices. Or else you yourself become guilty of Misprision of Felony 18 USC 4, Misprision of Treason 18 USC 2382, and Seditious Conspiracy 18 USC 2384.

Ignorance of the law is no excuse, especially when I have given you the law and put you all on notice of what the law is. Ordinarily, under normal circumstances, you would have judge's immunity which would excuse your ignorance, as that is one of the privileges and immunities of a lawful and legitimate judge who is engaged in the legitimate duties of a judge of the Republic who is under the federal and or State constitutions. However, these are not normal times, and we are no longer under any federal constitution or under any legitimate rule of law at all, and have not been since the fraudulent elections in 2008/9, and as long as a non-natural born Citizen usurper occupies the Office of President. As long as you judges, and the prosecutors, are all going to keep on lying by claiming that a natural born SUBJECT of immigration and naturalization at birth under the 14th Amendment, i.e., a "naturalized citizen" at birth, which is what Obama, Cruz, and Rubio all are, is the same as an Article II "natural born Citizen", which is FALSE and a lie told by attorneys, judges, and prosecutors in order that fraudulent imposters can occupy the Office of President, then the government has been unlawfully and illegally altered and overthrown by the privileged classes, you judges and prosecutors and attorneys. Overthrown to become a foreign outlawed jurisdiction, which is foreign to the Constitution and to the People, and defines the courts to be a religious venue, not a secular venue, and we natural born Citizens are no longer, and in no way, duty-bound to recognize any claims of immunity, because you are not valid judges engaged in the legitimate duties of a judge of the Republic under any constitution, State or federal. Instead, you are only judges of a Constitutionally-banned monarchic and religious form of government, engaged in criminal political activity from the bench with every case you try, and your immunity just went bye-bye because you are committing crimes from your office as a judge of a legally non-existent government, most likely without even realizing it if you cannot explain the law governing natural born Citizen status.

You cannot be guaranteed that the next President will not be a natural born Citizen such as the non-natural born Citizen Obama, so you cannot guarantee that you all will be able to continue your criminal political activity from the bench with impunity, protected in the

High Treason, Seditious Conspiracy, criminal corruption, and criminal racketeering which has defined your tenure under Obama. Judgment day could very well be at hand for all you judges, and you could all be facing very serious criminal charges and even personal liability.

The Plot to Assassinate Mr. Donald Trump

I believe that I am in possession of constructive knowledge that there is a plan to assassinate Mr. Trump. I have the prime suspects identified and the motive proven as a scientific matter. This scientific proof of the motive is enclosed; see the document entitled *The True Meaning of Article II "natural born Citizen"*. This document is the summary of the legal scientific findings of the definition of nbC status, taken from the first six chapters of my science book *Demonic Positivism versus the Science of "natural born Citizen"*, which explains the objective scientific basis of the definition and meaning of the Article II natural born Citizen clause in great detail, and also documents the criminal obstruction of justice which I have experienced in the courts, and from the FBI and DoJ.

You all had better hope and pray that Mr. Trump is NOT assassinated, because if he is, then you will all be implicated as co-conspirators in his murder, with the motive of preventing him from attaining Office in order to prevent your exposure as false and fraudulent seditious traitor judges of a false religious venue court system that you yourselves have created by your own criminal negligence and criminal sedition lies that a natural born SUBJCT is the same as a natural born Citizen. You judges have all been fraudulently acting under the color of law for the last 8 years, defrauding the Constitutional Republic and the natural born Citizens for your income and salary benefits, crimes which you are all guilty of over the last 8 years under the usurper Obama. Naturally, you all have a motive to kill Mr. Trump so that he will not attain the Office and be able to investigate you all, and have you all arrested and put on trial for your crimes of sedition and treason, criminal fraud, criminal obstruction of justice, theft, and maintenance of the overthrow of the Constitutional Republic. These are all crimes that you are all guilty of as complicit actors because you did not resign when Obama came to power illegally and unlawfully, crimes that you have no immunity for whatsoever as you are not even lawful valid judges of the Constitutional Republic and are just using your judges' offices for the commission of crimes since 2009. These crimes you are committing carry the death penalty under U.S. law; so naturally, you would want to see the bona fide natural born Citizen candidate, Mr. Trump, assassinated, which would solve your problems and permit you to continue your criminal activity from the bench with impunity.

Who else is a suspect in the plot to murder Mr. Donald Trump? Who stands to lose the most or gain the most, by preventing a bona fide natural born Citizen from attaining the Office of President? Given that Obama is not a natural born Citizen and he knows it, as does his backers George Soros and the Chinese government, which funded his criminal political activity and the overthrow of the Constitutional Republic, obviously Obama and his financial backers, George Soros and the Chinese government, stand the most to lose if

the science of natural born Citizen is discovered and revealed, and a bona fide natural born Citizen becomes President. Then Obama will be tried and executed for his crimes, and George Soros will be arrested and brought to justice and all of his financial assets seized under RICO statutes. So the motive is obvious, and the Prime Suspects in order of probability are:

- 1) Obama in league with George Soros and the Chinese government, which both helped fund Obama's takeover and overthrow of the United States to place us under fascism.
- 2) The Military High Command and Military-Industrial Complex. If Mr. Trump attains the Office, he could arrest all the Military High Command and have them all tried for High Treason and executed, and he would be totally within his rights under U.S. law. So they obviously want to see Mr. Trump killed.
- 3) The Congress and News Media Empire moguls. By law, as President, Mr. Trump could arrest the entire Congress and hand them all over to the military for trial, for seditious conspiracy to foment rebellion and insurrection via Presidential elections in order to overthrow the United States Constitutional Republic, and for maintaining the overthrow for 8 years! The news media owners and operators of CNN, MSNBC, FOX NEWS, etc., could all be arrested, put on trial, and sent to prison or executed, and all their financial assets confiscated under the RICO statutes, for their complicit role in overthrowing the United States government and for their role in maintaining the overthrow for 8 years by making fraudulent misrepresentations of the law governing nbC status.

As you can plainly see, you all have plenty of motives to kill Mr. Trump, and it is you, the government employees, who are the prime suspects with the biggest motive to see him dead. Even the Secret Service has plenty of motive to want Trump dead, to prevent exposing how the Secret Service has been protecting and maintaining a criminal usurper non-natural born Citizen in the Office of President for the last 8 years. Naturally, when Trump is assassinated, which I fully expect, you government employees and news media criminal fascists will try to make it look like an angry lone wolf radical in order to cover up the truth, such as was done with President Kennedy, so as to not have a trail back to you, but it is far too late in the day to fool us. We have already figured out who the actors are and what the motive is.

How to Save Face and Obtain Immunity

I don't think this is a very acceptable situation for our esteemed honorable federal judges who are most likely just victims of the fraud Obama, the same as I am, and just victims of your own ignorance of the meaning and definition of Article II natural born Citizen, which I am personally willing to overlook as a tribute to your years of valid service as lawful judges before Obama came on the scene. So, I would like to provide all of you with immunity before the elections, in case Mr. Trump is murdered, or if a legitimate natural born Citizen becomes President (Mr. Trump) and an investigation is begun to discover the truth, which will eventually happen, and then you will all be in a very bad

position, having to answer some very embarrassing and humiliating questions, which I do not think you want to have to answer.

Therefore, by providing you all with the law now, you can then say that you did not know but it has just come to your attention, and then you can just forward the evidence and documents to the appropriate prosecutors at the State and Federal levels, and insist that they immediately investigate my claims and interview me as a witness for the federal judges and federal employees who now wish to get under the Law jurisdiction of Article III, Section 2 and protect themselves with legitimate governmental immunity. Then you will all be covered, and no one will be able to accuse you of complicity in the overthrow of the Constitutional Republic, or complicity in Mr. Trump's murder, if that should happen. The buck can then pass to the prosecutors' offices, and it will be up to them to explain themselves, not up to you judges. In this way, you will be seen to be patriotic, loyal, competent, and doing your jobs and acting responsibly, and you will all be immunized going forward should a legitimate natural born Citizen President get into Office. You're welcome.

Please also read the three other documents enclosed. They document further evidence of the criminal obstruction of justice and document how Obama's illegal presence in the Office of President is interfering with the administering of the legal system and preventing it from functioning at the State level.

I have also written a book entitled *Demonic Positivism versus the Science of "natural born Citizen"*.
