Dear FBI Agent or Federal Marshal,

Please find documents enclosed which have all been given to all of the judges of the Madison County Circuit Courts in Indiana, and to all of the judges of the 7th Circuit Federal District Courts in Indianapolis. This same packet that has been given to the FBI and the Federal Marshals has also been given to the Secret Service, and sent to Mr. Donald Trump. I am sending out these documents and packets and a copy of my book *Demonic Positivism versus the Science of "natural born Citizen"* to you, so that you will all be in possession of the objective scientific evidence and knowledge of law which is needed in order that the judges, prosecutors, the FBI, the Marshals, and the Secret Service can do their jobs and protect themselves with lawful governmental immunity should Mr. Trump be assassinated, or should he get into Office as a bona fide natural born Citizen President and proceed to prosecute the complicit.

You have actually all been operating under the false color of law for the last 8 years without realizing it, thus you have absolutely no governmental protection of immunity from criminal prosecution should Mr. Trump be assassinated, or should he attain the Office of President as a bona fide natural born Citizen. You will all need immunity protection from criminal prosecution for the crimes of Misprision of Felony 18 USC 4, Misprision of Treason 18 USC 2382, and Seditious Conspiracy 18 USC 2384. These are the crimes you have all committed over the last 8 years which have fostered the fomentation of rebellion and insurrection within the United States via Presidential elections, in order to overthrow the Constitutional Republic of the United States and maintain a fraudulent non-natural born Citizen usurper in the Office of President, for 8 years now, an act of High Treason which you are all guilty of, and which carries the death penalty under U.S. law. And now you are at it again, because both Mr. Cruz and Mr. Rubio are not natural born Citizens either.

If there is any threat of assassination of Mr. Trump, then the FBI, the Marshals, and the Secret Service are among the prime suspects, on the short list of suspects with the motive to kill Mr. Trump, in order to prevent your exposure for your crimes under the illegal and Constitutionally-outlawed Obama regime. You have no one to blame for this situation except yourselves. Please read the enclosed documents, particularly the letter to the federal judges in the 7th circuit District Courts, where I elaborate the situation to them.

Even though you are all prima facie guilty, I suspect that you agents in the FBI, the Marshals Office, and the Secret Service have not intentionally committed all of these terrible crimes of overthrowing the Constitutional Republic on purpose. But it has indeed happened, and you have illegally and unlawfully maintained Obama in power against the Constitution and rule of law, by presumably unintentional mistake due to your ignorance of the science of jurisprudence and your ignorance of U.S. law which has caused you to not realize or comprehend the scientific and objective definition and meaning of Article II "natural born Citizen", which proves that Obama is not one, knowledge which would permit you to then do your job to protect the Office of President. Not to protect the 'man' who occupies the Office illegally and unlawfully, as it is not your job to protect a fraud like Obama and maintain him in power against the Constitution, which is what you are all guilty of doing for the last 8 years. This is why, if Mr. Trump is murdered, the FBI, the Marshals, and the Secret Service will be prime suspects in his murder, because you are the ones with a perfect motive to see him eliminated in order to cover-up for your crimes of High Treason.

Personally, I think you are all just victims of the fraud Obama, and of the criminal outlaw George Soros and the Chinese Communist government, just as I am, and victims of your own ignorance of the law governing the definition and meaning of Article II "natural born Citizen". It is George Soros and the Chinese government who backed the overthrow of the Republic through financial support for the fraud Obama. Thus you have been duped into being set up as the fall guys for the murder of Donald Trump, or of any legitimate bona fide natural born Citizen candidate (except Hillary Clinton), who decides to run for the Office of President.

### **How to Save Face and Obtain Immunity**

I don't think this is a very acceptable situation for our esteemed honorable FBI, Marshals, and Secret Service agents, who are most likely just victims of the fraud Obama, the same as I am, and just victims of your own ignorance of the meaning and definition of Article II natural born Citizen, which I am personally willing to overlook as a tribute to your years of valid service as lawful government agents before Obama came on the scene. So, I would like to provide all of you with immunity before the elections, in case Mr. Trump is murdered or if a legitimate natural born Citizen becomes President (Mr. Trump) and an investigation is begun to discover the truth, which will eventually happen, and then you will all be in a very bad position, having to answer some very embarrassing and humiliating questions, which I do not think you want to have to answer.
