Dear Judge or Agent;

Now that Mr. Trump has been apparently elected as our new President, the judgment day that I warned you about in my previous letters surrounding the events on March 18, 2016, has now come to pass. Now you, as all government employees, must consider yourselves to be under criminal investigation for your roles in rigging elections with non-qualified candidates, to permit illegal elections for the purpose of inciting insurrection and rebellion against the Constitution and rule of law, to overthrow the government and maintain it as overthrown for 8 years, for levying war against me and my family, against the natural born Citizens of the Republic, and against the Constitution, and against the legitimate government of *We the People*.

As this war against us is still happening, it appears that you judges, Secret Service agents, and U.S. Marshals, are all working in concert with the FBI, DoJ, and other government agencies to maintain the overthrow of the government, engaged in inciting rebellion and insurrection and violence in the society through violent hateful riots in the streets against the election of Mr. Trump, against those who voted for Mr. Trump, and against me as a natural born Citizen, riots which are now occurring in multiple cities and States across the nation. It appears that you are all engaged in Sedition and Treason and levying war upon the society with institutionalized hate and defamation, and institutionalized sexism and racism, directed against the People and against

the Constitution and rule of law. You obviously have not done your duty to see that Obama is arrested and removed from Office as the illegal mobster criminal usurper and fake non-natural born Citizen that he is. Because this had not been done, I can only conclude that you are all criminals, cowards, and traitors who are working against the election, and against President-Elect Trump, for the purpose of inciting hatred and murder against Mr. Trump, the bona fide natural born Citizen President-Elect, and against me and other natural born Citizens, and against those innocent voters and electors who have elected a bona fide natural born Citizen to be the next President. So that we may be murdered by the violent brainwashed society, that government employees have brainwashed with the fascist lie that a natural born SUBJECT of immigration and naturalization under Article I and under 14th Amendment authority, is a natural born Citizen under Article II authority, in order to maintain Obama in Office illegally and against the Constitution and rule of law, and to prevent President-Elect Trump from assuming the Office as a lawful President, so as to protect yourselves from indictment for your crimes, and to protect your own selfish interests, your name and reputations, instead of courageously taking your lumps and doing your duty to be public servants of the People. You are making it very difficult for me to testify on your behalf in the future, and thereby grant you that lawful immunity protection, that I had offered to you back around March 18, 2016.

In the off-chance that I am wrong about you, then here is your opportunity to prove it, and garner my support and testimony on your behalf, so that you may gain that immunity protection from these accusations, in order to protect you from criminal and civil prosecution.

Here is what I want to believe about all of you, but I cannot prove at this time because you have not sufficiently proved to me that you are listening and following my advice.

What I really want to believe, is that perhaps you did accept my testimony and proof of the law governing nbC status, and you did take judicial notice that the government has been overthrown because Obama is not a bona fide natural born Citizen (nbC), and you are listening to me, but you realize that you are legally hamstrung to do much about it without a bona fide nbC in the Office of President. Perhaps you did in fact instruct government insiders to prevent Cruz and Hillary Clinton from becoming President, and went to work to ensure that Mr. Trump, the only viable bona fide nbC candidate, became the President-Elect. Assuming that this is the case, in order to provide a light most favorable to the state and to you government employees, you must now finish this job that you started, or else there cannot be any legitimate legal transference of power to Mr. Trump and to Mr. Pence.

## QUO WARRANTO

Here is the legal situation, in case it has escaped your understanding. In order to testify on your behalf, I must assume that you are just ignorant of the law and of your duty, and you are ignorant of what must be done, not that you are actually working with criminal intent to prevent the rule of law, or intentionally inciting the murder of President-Elect Trump and myself.

There has not been any lawful or legitimate artificial sovereign authority to even bring a quo warranto since 2008. As long as there is no nbC President, then there is also no legitimate DoJ to bring quo warranto. Neither the Congress or the DoJ or Courts, for that matter, have any

lawful authority to do anything but remove and replace Obama, in order to regain their sovereign immunity and regain their ability to enforce the rule of law. Installing a non-nbC in the Office is an unconstitutional act that eviscerates the lawful ability of all branches to exercise sovereign authority. Here is what the Supreme Court has to say on the issue.

An unconstitutional act is not law; it confers no rights; it imposes no duties; affords no protection; it creates no office; it is in legal contemplation, as inoperative as though it had never been passed.

[*Norton vs. Shelby County*, 118 U.S. 425, p. 442.]

Now, a Quo Warranto petition must be brought by General Dunford, the Chairman of the Joint Chiefs of Staff, which represents the military legal authority, and by the Speaker of the House of Representatives, Paul Ryan, which represents the civilian legal authority, against Mr. Obama, in order to legally remove Obama from Office before his term is up, in order to effect a lawful and peaceful transition of power and authority to the bona fide natural born Citizen and legitimate President-Elect, Mr. Trump.

Besides you judges, they are the ones whose offices are eviscerated to not have any lawful or legitimate authority, due to Obama not being a nbC, and as long as he occupies that Office without lawful authority. Paul Ryan must bring a Quo Warranto claiming that he himself represents the lawful legitimate government, which represents the civilian branch of government informing Obama to step down voluntarily upon presentment of the facts and law already provided to the court by me which proves that Obama is not a natural born Citizen. This is necessary so that Paul Ryan can take his lawful place as the interim President. And then if Obama refuses, not only does Obama prove his intent and his crimes, but then it is a military issue, and as General Dunford is injured in his Office because he cannot take orders from Obama and do his job and duty, he must arrest Obama and hold him for trial, either in a military court martial, or hold him and hand him over to the civilian authorities once the Congress deals with the crisis and installs Paul Ryan to finish the term.

Otherwise, if this does not happen, then there is *no* representative Congress which represents the consent of the natural born Citizens *who can certify the election*, and Mr. Trump and Mr. Pence will not have the lawful authority to assume Office, and their elections will be legally nullified, because their elections will only have the consent of the news media, voters, and electors, but it will not have the consent of the natural born Citizens. Thus Mr. Trump's presidency would be just as unlawful and illegitimate as Obama's. Furthermore, you will all then be indicted as co-conspirators who are obviously working with the rioters in the streets, in order to illegally nullify the election of a legitimate bona fide natural born Citizen President-Elect, for obvious selfish interest gains and benefit, of which I had already accused you and elaborated in my criminal complaint to you, which is now being proven true by the events on the ground in real time.

It is not my duty or responsibility to make this happen, it is YOUR DUTY! No one is going to listen to me, but they will listen to you, or if not they will prove thereby their criminal intent to you, and they will be arrested, indicted, and tried for their crimes, and you will all be the expert witnesses against them.

Therefore, I am instructing you to inform and order General Dunford and Paul Ryan of the legal situation, and demand, with an order if they will not voluntarily comply, that they bring a Quo Warranto on their own behalf and on the behalf of the People and Constitutional Republic, in order to do their lawful duty to remove Obama, and thereby restore the lawful sovereign authority of their offices, which the law and Constitution demands. And in order to prove their loyalty and allegiance, which will grant them legitimate immunity and prevent them from the appearance of criminal behavior. If they refuse to do this lawful thing, which is their right and duty to do, then thereby they prove their criminal intent, and they commit contempt of court, for which they can be arrested by the U.S. Marshals and brought before the court and before Guthrie to answer for their crimes.

There is no point in me bringing this suit, as you have already determined that I am ‘trailer trash’ and a ‘deplorable’, just a slave with no recognized citizenship rights or due process rights, or right to petition under the 1st Amendment, as you have determined that the 1st Amendment does not apply to me, according to you judges, because I am a genuine natural born Citizen, and you refuse to recognize the law governing nbC status, and you refuse to recognize my status as a genuine natural born Citizen with natural inherited political rights, inherited from my citizen father. I don’t know that you judges have accepted the law as I have informed you, but you obviously hate me and are out to murder me, as is evidenced by your previous criminal activity against me in my previous two attempts to sue Obama and others for these crimes. And as evidenced by the fact that Obama still occupies the Office illegally, even after I have put you on notice multiple times. Therefore, I have no reason to believe that it is even safe for me to bring this suit to compel them. You yourselves can do it simply as citizens, if not as government employees, because as employees, your offices are all eviscerated now, too, so even you can bring this Quo Warranto if you wanted to. *Why aren’t you?*

I am purposely not sending this to President-Elect Trump at this time, in order to see if you judges and agents are going to do your duty to inform President-Elect Trump, now that he has the security clearance, as you are compelled by law to inform him of the facts and evidence and law which I have provided to you. And, in order to see if you bother to inform and compel General Dunford and Speaker of the House Paul Ryan. Otherwise, if by some miracle President-Elect Trump is not assassinated, and is actually illegally inaugurated and becomes a bona fide nbC President but with no lawful authority, with his own (unlawful) DoJ, then I (or my agents, should I be murdered) will be in the position to inform his Administration and his DoJ regarding your actions or inactions in this matter, and how you have conspired to eviscerate his authority and have conspired to incite riotous insurrection and violent rebellion to murder me and the voters who voted for Trump, murder natural born Citizens, murder President-Elect Trump, and murder Vice President-Elect Pence. Then I am sure he will bring you all up on criminal charges, and you can all go down the drain when he gets to ‘draining the swamp’, which he has already promised is his mission. I don’t think you want that to happen.

Therefore I strongly urge you to follow my instructions and carry through with your duty, if you want me to be in a position to testify on your behalf, so that you will have immunity from being prosecuted as criminal Seditious and Traitors using your positions within the government to levy war against the United States and against natural born Citizens, to prevent President-Elect Trump from securing his constitutionally protected political right to assume the Office of President, WITH lawful authority.
