To: The Madison County Circuit Court judge who issued the fraudulent Court Order for me to fill out the application for jury duty. You know who you are.

YOU ARE HEREBY PUT ON LEGAL NOTICE

I am sending this to you in response to the automated illegal and unlawful Court Order in preparation to issue a Summons for jury duty, which I received from your false religious court (See Attached People's Exhibit A), attempting to illegally and unlawfully draw me into your religious venue, attempting to illegally draw me into the criminal fraud and misconduct and corruption that defines the place known as "The Circuit Courts of Madison County" in the State of Indiana. Under Obama, or under any non-natural born Citizen false President, "The Circuit Courts of Madison County" are a RELIGIOUS VENUE, in violation of the First Amendment's Establishment Clause. They are no longer a State secular legal venue in a Republic under the State or federal constitutions, or under any rule of Law, with a separation of Church and state, which are capable of issuing legitimate civil process, or conducting legitimate trials. These are actually only the religious courts of Emperor-God-King Obama, the false President, and Black Hitler, courts stacked with his fascist criminal sycophants, as if I am living under Hitler in Germany as a Jew in the 1930's, stripped of all my rights as a natural born citizen of Germany. Just like those German Jews under Hitler, so have the natural born citizens of the United States, i.e., the Article II "natural born Citizen", been stripped of all of their identity and rights as citizens under the Constitution, by the criminal willful acts of Obama, the willful criminal acts of Congress, and by the willful and criminal outlawed acts by the States under Obama, and by the willful fraudulent acts of the fraudulent County Courts under Obama, who are all now acting to incite unlawful violence against natural born Citizens to strip us of our rights, identical to a Jew under Hitler.

You have no one to blame for this situation except yourselves, the Indiana State Secretary of State, the Indiana State Attorney General, the Governor of Indiana, the same officers of the other 49 States, the Congress and various federal and State judges, attorneys who are all making fraudulent misrepresentations of the law and of the definition governing nbC status in court and in the public media press, the ignorant voters who voted for a non-qualified candidate twice, the Federal Elections Commission, the Department of Justice, FBI, Nancy Pelosi, the Electoral College, the Democrats and Republicans, and Obama. Your beef is with them, not with me! They have stripped you of your status as a legitimate secular State court with legitimate judges and a legitimate due process and civil process, and they have turned you into a religious venue that has stripped me of my rights to be a jurist, with their lies that a natural born SUBJECT of immigration and naturalization at birth (naturalized citizen at birth) equals a natural born Citizen at birth who is NOT born as a subject of immigration and naturalization at birth, not dependent upon Congress for their right of citizenship to be bestowed as a legal right. The natural born SUBJECTS are banned in Article II from being President. As a legal matter, the

right to be a natural born Citizen is an inherited Natural Right, declared in Article II in order to secure the Natural Law right to be the head political leader of the country to pass down from a citizen father of a State of the Union to his offspring, not a bestowed legal right. Both myself and also the legitimate judges and legitimate Circuit Courts of Madison County, as those courts and judges are defined by the State and federal constitutions under a Republic with a natural born Citizen President, have been victimized, because now I cannot even reply to your Court Order, which puts me in jeopardy of contempt of court, nor even respond to a Summons for Jury Duty, and you cannot even lawfully send out a court order or a Summons for Jury Duty. Thus you now have all of the evidence required to prove that Obama's illegal occupation of the Office of President is directly interfering with, and obstructing and preventing, both the administering of the rule of law by the Madison County Circuit Courts, and is preventing me from securing my right to be on a jury of my peers, or to reply to a court order and lawfully refuse it, without being in jeopardy of charges of contempt of court.

You are hereby put on legal notice that the Court Order is legally defective and without lawful warrant, due to the fact that Obama is not an Article II "natural born Citizen", and thus the legitimate Madison County Circuit Court has no legitimate lawful ability to engage in a legitimate or lawful civil process to Order or Summons anyone as a potential jurist, nor to conduct any trials without stripping the accused of their rights under the Constitution, and not without committing fraudulent misrepresentation of themselves as being lawful legitimate representative State or County judges of a Constitutional Republic who are under the Constitution and under the rule of law; which none of the State, County, or federal courts or judges are under, or have been under since Obama came to power illegally and unlawfully in 2008/9. Nor can the courts or State of Indiana guarantee to me, the protection of the law and of my rights as a jurist, which depends upon recognizing my status as a natural born Citizen, which the State, County, and federal courts do not recognize, and will not recognize due to the obvious financial and reputation conflicts of interest that now exist for the judges and State and County employees, which is caused by Obama's illegal and unlawful occupation of the Office of the President without Constitutional authority, because he is not a natural born Citizen.

The State, County, and federal judges had one duty and one duty only to do when Obama came to power, and that was to RESIGN in order to live up to their oaths to defend and protect the Constitution of the United States and the legal system, and to enforce their loyalty and allegiance oaths to the Constitution and to the People. None of the federal judges, State, or County judges have resigned in protest of the overthrow of the Constitutional Republic by Obama and by the State's and Congress' employees, thus it is clear to the natural born Citizens that all of the judges and prosecutors at the federal, State, and County level, have all disavowed their oaths and their loyalty and allegiance duty to the Constitution, to the natural born Citizens, and to the rule of law. The State and federal employees have granted themselves complete and total unfettered authority and control to define natural born Citizen status according to their own arbitrary and subjective beliefs, because the definition is not written down for them in a form that they can comprehend without years of law school; and even then they do not comprehend it, or give a damn. Thus they have, in fact, taken it upon themselves to ignore the science of

jurisprudence which defines these matters objectively and scientifically, and instead they redefine nbC status incorrectly and contrary to Nature and U.S. law by their own arbitrary and subjective religious opinions, in order to permit Obama, Rubio, and Cruz to illegally be on a ballot and to illegally be the President without lawful Constitutional authority, and to thus keep their jobs as judges and government employees. In effect, these government employees and judges, by their severe negligence and incompetence and complete and total unfettered power and control at their disposal to re-define nbC status to be contrary to the Constitution and U.S. law, have caused the secession of the States from the Union, and as a legal matter, have unlawfully dissolved the Union by default. And now the judges have instead sworn their allegiance and loyalty to the fraud Obama, not to the Office of President, or to the State or federal constitutions, and the judges have pledged their loyalty and allegiance to the monarchy and religious form of government now unlawfully erected by Obama and the Congress in place of the Constitutional Republic. Now the judges, attorneys, and prosecutors are all about the forced religious worship of mankind. The idea of Obama being "President" is a violently-enforced religious point of view, not a scientific point of view or a legal point of view, but a religious opinion view which is just forced upon natural born Citizens without consent, forced by the privileged classes like attorneys, judges, prosecutors, and Congressmen, or forced upon society by voters, news media, FBI, Secret Service, etc., i.e., forced by the minority population consisting of government employees and voters, forced upon the majority population who are not government employees, without consent, contrary to U.S. law, and contrary to the Constitution, in order that the State, County, or federal government employees can line their pockets and keep their lucrative jobs, in violation of the First Amendments' Establishment Clause, and in violation of criminal fraud and criminal racketeering codes. The controlling religious point of view of the minority of the population that the majority are all forced to live under, a minority consisting of government employees who dictate to the rest of society what a natural born Citizen is and so what our form of government is, has been dictated to us to be a Monarchy and Religious government with natural born SUBJECTS of Congress only. Which is what Obama is, a natural born SUBJECT of Congress at birth, that we all just lie about and call 'President' or 'natural born Citizen'. The government employee does not permit the citizen to view the government as a Republic with citizens who have sex to create more citizens naturally with the sex act, citizens who are born with, and have, the status of a natural born Citizen inherited; which is a scientific point of view which is objective, and not subject to 'opinion', not a religious point of view which is arbitrary and subject to a point of view or 'opinion'.

As State employees under Obama, the Madison County judges are not committed to the rule of Law, to their oaths of office, to the Constitution, or to the protection of my rights or to the protection of the rights of natural born Citizens, since the 2008/9 fraudulent Presidential elections. You have all committed yourselves to the forced religious worship of Obama to be a natural born Citizen when he clearly is not, for your own personal advancement and financial advantage over natural born Citizen jurists and the rest of society, in order to set yourself up as GODS and high priests of a subjective and arbitrary jurisprudence, not judges of a scientific and objective lawful legal system defined by the State and federal constitutions, so that you can line your own pockets with income stolen

from the natural born Citizens. Thus you are just seditious traitors and a den of thieves, criminals in a religious venue of your own criminal making, not a legitimate constitutional court of the Republic, no valid court of Law to Order me to, or to Summons me to. You have all just been defrauding the defendants in County and State court cases, and defrauding the American citizens and the citizens of Indiana for your income and salary benefits, and for your name and reputation benefits, for the last 7+ years! **JUST LIKE OBAMA AND CONGRESS!** At the expense of the natural born Citizens, whose identity as citizens you continue to refuse to recognize, even 7+ years **AFTER** Obama has overthrown your country as a non-natural born Citizen **USURPER**. And even after I have already put you, and the federal courts, FBI, DoJ Congress, etc., on legal notice of these facts in writing and with lawsuits the last time I refused your bogus Court Order. Fraud evidenced by the fact that Obama has not been arrested yet as the imposter and seditious traitor that he is, and neither was I held in contempt of court, because last time the judge just swept the issue under the carpet, which is the criminal act of misprision or felony and misprision of treason. Thus the Court Order that you have now sent to me is evidence of criminal activity in the courts, after you already were put on notice of my refusal two or more years ago and I put the court on notice that Obama is not legitimate, when you just ignored the issue and my refusal to your Order that last time the court sent a Court Order for me to appear as a potential jurist, and the court did nothing about it. This is all now prima facie evidence of the criminal fraud, criminal obstruction of justice, criminal racketeering, seditious conspiracy to prevent the Constitution from operating, and seditious conspiracy to commit High Treason and maintain High Treason by maintaining Obama in power against the Constitution. This constitutes an act of **CIVIL WAR** that the Circuit Courts of Madison County and judges have been engaged in for the last 7+ years! Absent a Presidential Pardon from a bona-fide natural born Citizen President, the judges of Madison County are to be immediately arrested and put on trial for their war crimes, and are in no position to be issuing court orders or summons to potential jurists!

The Court Order in preparation to issue a Summons which you sent to me, has all of the form and appearance of a lawful legitimate court order, but none of the legal substance of one, because Obama is not a natural born Citizen and is a false and fraudulent President. The Court Order is just false color of law, not legitimate substantive law. This is happening because those human judges who are supposed to oversee the automated process, like you, have not told the computers that Obama is not a natural born Citizen and to stop issuing court orders and subpoenas to potential jurists until the Republic is restored. They are not doing their jobs, just like none of you government employees have been doing your jobs and have been **AWOL** for 7+ years, which has now led to me having to refuse a Court Order, **AGAIN**, which now puts me in legal jeopardy of contempt, **AGAIN**, a position into which the County Courts and State of Indiana and Congress have criminally engineered and maneuvered me by **THEIR FRAUDULENT CRIMINAL NEGLIGENCE AND MISREPRESENTATION OF THE LAW!** **YOU HAVE NO RIGHT! TRAITORS!**

Please find the document enclosed entitled, The True Meaning of Article II “natural born Citizen”. Therein I explain the law governing nbC status as a scientific and objective

legal matter, with controlling points and authorities of U.S. law and Natural Law, proving the case against Obama, and against the Madison County Circuit Courts and judges, which is objective, scientific, and independent of my 'opinion' or point of view, or of anyone's 'opinion' or point of view, because it is all FACT and SCIENCE based, based upon natural observations of the natural order to discover the natural rules, not based upon subjective 'opinion' and made-up make-believe.

Here is a thought. Under this historic and unprecedented situation, a case of first impression in U.S. history, and now that I have refused your Court Order, again for the second time, and I have refused to be on a jury as long as Obama occupies the Office as an illegal usurper, as both are my right under U.S. law, and I have explained to you how you have no legitimacy now, how you are a religious venue and not a valid legal secular venue, and how you have no lawful authority at all to Order me about as a natural born Citizen when the Office of President is not occupied by a representative of the natural born Citizens, now you are a witness yourself to the inability for you to order anyone around as long as Obama illegally occupies the Office of President without Constitutional authority. So why then don't you do your job to report what you are witnessing in my correspondence and refusal, report Obama's criminal overthrow of the Constitution and criminal obstruction of justice and his criminal prevention of the rule of law at the Madison County Court level, and report these crimes to the federal and State authorities so that they can begin their criminal investigation and begin questioning me as a witness for the State and County against the fraud Obama and against the fraudulent federal government, as is your job and the job of the State and federal prosecutors to do, so that they can arrest Obama for the fraud imposter that he is, in order to restore the sovereignty of the State of Indiana and your sovereignty as a County Court and judge, and thereby cure this defect in your legitimacy and authority at the State and County level, so that I can recognize you to be legitimate, and you can then lawfully order me to court as a potential jurist? Then you will be a whistle-blower hero who restored the sovereignty of the State of Indiana and the Republic, and dealt a serious blow to governmental fraud and governmental criminal corruption! Then you can look good, be a hero, and then I can have my identity as a natural born Citizen restored, my right to be a jurist restored, my voting rights restored, my right to due process in courts restored, my right to be free from governmental religious tyranny, and from governmental religious persecution by religious venue judges and by the religious society of Obama Cult worshipers, restored, my right to a representative government restored, and my right to have my liberty and freedom rights secured by the Constitution, restored?
